- Interested Agencies can be present at the time of opening of bids.

Terms and Conditions

- 1) Sealed bids in prescribed proforma must reach on or before 09.01.2018 (upto 3.00 PM).
- 2) EMD of Rs.5000/- to be deposited along with quotation in separate envelope. Bids without EMD will be summarily rejected. EMD can be in the form of DD in favour of "Pushpa Gujral Science City" payable at "Kapurthala" or in cash for which receipt has to be enclosed with the bid.
- 3) Rates quoted should be valid for one month. Scrap buses will be disposed of 'as is where is basis'. No documents of buses are available with PGSC.
- 4) Successful bidder will deposit the quoted amount within 10 days from the date of issue of order.
- 5) In case, highest bidder does not deposit the quoted amount within stipulated time, the EMD will be forfeited and order will be placed to next highest bidder.
- 6) EMD of successful bidder will be adjusted in the quoted amount.
- 7) EMD of unsuccessful bidder will be returned after one month or successful bidder has deposited the bid amount with PGSC, whichever is earlier.
- 8) No interest will be payable on EMD
- 9) The successful bidder will give Affidavit as per Annexure-I at the time of depositing of bid amount.
- 10) Picking up of material from PGSC site will be the responsibility of the bidder.
- 11) Director General, PGSC reserves the right to accept or reject any or all the tenders without assigning any reason.
- 12) Any dispute or difference under or arising out of in respect of the Agreement/ Accepted Contract may be referred to the sole Arbitration of a person appointed by the Director General, Pushpa Gujral Science City, Kapurthala & his decision in the matter will be final & binding on the contractor/firm/agency. The arbitration shall be carried out as per Arbitration Act. 1996 & rules made there under as amended from time to time.
- 13) Legal jurisdiction will be judicial courts of Kapurthala District.
