- 5) Bill for the payment be sent to the Administrative Officer, Pushpa Gujral Science City, Jalandhar Kapurthala Road, Kapurthala.
- 6) PGSC reserves the right to accept or reject any or all quotations without assigning any reason thereof.

➤ **Earnest Money Deposit (EMD)**

The bidders will need to deposit EMD of Rs. 3,000/- (Rs. Three Thousand only) along with the quotation. EMD can be paid either through Demand Draft in favor of "Pushpa Gujral Science City", payable at "Kapurthala" or RTGS as per detail below:

➤ **Date of opening of Bids**

The date of opening of bids will be intimated to all the participating firms through email/phone. Kindly mention your email/phone number on the envelope.

➤ **Payment**

Bill for the Payment may be sent directly to the Administrative Officer, Pushpa Gujral Science City, Jalandhar Kapurthala Road, Kapurthala. No advance will be given.

Payment will be released after 20 days from the date of delivery/Installation of translide to the satisfaction of PGSC.

TDS/ Levies will be deducted as applicable time to time, if any

➤ **Delivery**

The translide will be supplied and installed at PGSC within 4 weeks from the date of issue of the order.

➤ **Penalty Clause**

In case the bidder fails to supply the material within the time specified in the agreement, he shall without prejudice to any other right or remedy available under the law, pay compensation the amount calculated at the rates stipulated below or such smaller amount as the Director General may decide (whose decision in writing shall be final and binding). The bidder shall pay an amount equal to 1% (One percent) of tendered value

for every week or part of a week that the work remains uncommenced or unfinished after the expiry of the completion date. The entire amount of compensation to be paid under the provisions of the clause shall not exceed ten percent of the value of the accepted quotation.

➤ **Payment Schedule / Security**

Payment will be made on the supply and installation of Translide at PGSC, Kapurthala to the satisfaction of PGSC. 10% Payment will be retained as security and will be released after one year.

➤ **Performance Guarantee**

The supplier shall provide Performance Bank Guarantee valid for a period of 1 year from the date of Supply & fabrication of translide against manufacturing defects equivalent to 10% of the order value from a Scheduled Bank. The security so retained in the 'Payment Schedule' shall be returned on submission of Performance Bank Guarantee.

➤ **General**

- All damaged or unapproved goods shall be returned at the risk and cost of the tenderer and the incidental expenditure thereupon shall be recovered from the Contracting Agency / Supplier.

- **Jurisdiction**

In the event of any disputes, difference or controversies, arising between the parties hereto, out of or in connection with terms and conditions of this order, or any action taken hereunder, the parties shall explore the possibilities for an amicable settlement. In case amicable settlement is not reached, such dispute, differences, controversies shall be settled by Arbitration. The arbitrator will be appointed by Director General, PGSC, whose decision shall be binding on both the parties. The venue of such arbitration and all other legal jurisdiction shall be at Kapurthala.
